2024-2025 General Rate Application (GRA) – Proceeding ID 2024-013

Please find enclosed for filing with the Public Utilities Board (Board), Naka Power Utilities (Yellowknife)'s (Naka-YK) General Rate Application (GRA or Application) for the 2024-2025 Test Period.

This Application includes the request for determination of Naka-YK's 2024-2025 revenue requirement and other relief as requested throughout the Application.

The rate changes requested by Naka-YK in each of the Test Years are as follows:

As explained in Section 15 of the Application, Naka-YK is requesting interim approval to update its Interim Rate Adjustment Rider (Rider R) for implementation on November 1, 2024, to begin collecting the applied-for 2024 Revenue Requirement shortfall on a refundable basis.



Board approval is required on or before October 24, 2024, to implement the 2024 Rider R effective November 1, 2024. Any adjustments required to Rider R following a Board Decision will be made in a subsequent Compliance Filing.

Naka-YK is also requesting interim approval to update Rider R for implementation on January 1, 2025, to begin collecting the applied-for 2025 Revenue Requirement shortfall on a refundable basis. Details related to this increase are also discussed in Section 15 of the GRA.

To implement the 2025 Rider R, effective January 1, 2025, Board approval is required on or before December 20, 2024. Any adjustments required to the 2025 Rider R following a Board Decision will be made in a subsequent Compliance Filing.

Section 1 of the Application sets out an Overview that provides relevant context for the Application and the relief requested therein. Forecasts included in the Application were prepared based on the best information as at the time it was prepared. Forecasts were prepared by management, with the exception of the proposed Depreciation Parameters. Naka-YK engaged Concentric Advisors to prepare a Depreciation Study for this Application. Please refer to Section 6 for a summary of the Depreciation Study and impacts of the updated depreciation rates, and to Section 6.1 Attachment 1 for the full Depreciation Study.

Prior to filing the GRA, Naka-YK met with the City of Yellowknife (City). Based on those discussions, Naka-YK understands that the parties are supportive of a procedural schedule that includes a Negotiated Settlement process. The City and Naka-YK's initial interest in collaborating is encouraging as the parties have had success in the past and have realized regulatory efficiency, as well as public hearing cost savings through Negotiated Settlements. Accordingly, Naka-YK requests leave from the Board to conduct a Negotiated Settlement process pursuant to section 36.1(1) of the *PUA* and the Board's *Negotiated Settlement Guidelines*.



Naka-YK proposes the following process steps and timelines in connection with a Negotiated Settlement process.
